



PITCHES REGULATION

Rates are per day regardless of time of arrival.

The departure day will also be counted if this takes place after 10.00 am.

ARRIVAL: the pitches are available from 10.30 am till 12.30 pm and from 3.00 pm till 8 pm – till 9 pm in July and August.

We will keep at incoming customer's disposal the reserved pitch until 10.00 am of the following day. On arrival, guests are asked to hand in all passports. The management reserves the right to hold these documents for police registration. Just one will be kept till the payment of the balance.

DEPARTURE: on departure day, the pitches must be left within 10,00 am.

Due to delayed arrival or early departure customers must pay for the whole booked period, even though the pitch is afterwards occupied.

An early arrival doesn't authorize an early departure.

ANIMALS: are welcomed in all the areas of the camping (except where specifically forbidden).

PRE-PAYMENT: in case of cancellation, the pre-payment will be refund according to the booking's conditions.

COVID-19

VISITORS External visitors are allowed to enter and visit the camping by leaving an ID at the Reception. The entrance is free for the first hour; then the current prices will be applied and charged at the Reception. The management can stop the visits from external visitors.

MINORS Adults are responsible for both their children and for the minors travelling with them. Minors must always be accompanied by an adult.

ACCOMMODATIONS REGULATION

ARRIVAL

The accommodation is available from 3,00 pm till 9,00 pm. - July/August till 10,30 pm.

We will keep at incoming customer's disposal the reserved maxi-caravan or pitch until 10,00 am of the following day.

On arrival, guests are asked to hand in all passports. The management reserves the right to hold these documents for police registration. Just one will be kept till the payment of the balance.

DEPARTURE

On departure day the accommodation must be left within 10,00 am.

Departures outside office opening time do not allowed the check of the accommodation.

The deposit will be returned afterwards by bank transfer.

Due to delayed arrival or early departure customers must pay for the whole booked period, even though the accommodation is afterwards occupied. An early arrival doesn't authorize an early departure.

PRE-PAYMENT: in case of cancellation, the pre-payment will be refund according to the booking's conditions.

CAUTION:

At the arrival must give a deposit of € 100,00 cash which will be returned on departure after the check of the accommodation. In case of departure before opening time the amount will be transferred to you after the control (banking charges at your expense).
